ELECTRIC WORKS COMPLEX *Fort Wayne, IN*



The historic General Electric factory complex has been transformed into a 730,000+ square foot innovation district, supporting the world headquarters for the Do it Best Corporation, primary healthcare, a STEAM school, and over 10,000 square feet of innovation space.
